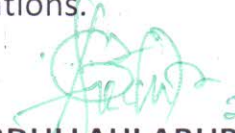
2. The monthly budget execution reports of the Government of Niger State of Nigeria for the month of January, 2021 on the COVID-19 related funds had been submitted to me.
