LAW TO PROVIDE FOR REVISED BUDGET 2020

BE IT ENACTED by the House of Assembly of Niger State of Nigeria and by the authority of same in the present State Assembly as follows: -

Short Title and Commencement

1. This Law may be cited as Niger State of Nigeria Revised Budget 2020 and shall come into operation of 1st day of June, 2020

Interpretation

2. By virtue of Section 121 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), 2020 Revised Appropriation Law of Niger State for the period of 1st June to December, 2020 shall be as set out in the schedule.

Recurrent Expenditure

3. (1) The sum of Forty-Nine Billion, Eight Hundred and Fifty-Nine Million, Two Hundred and Ninety-One thousand, Six Hundred and Forty-Nine naira, Thirty-One kobo (N49,859,291,649.31) only shall be appropriated as Recurrent Expenditure as specified in the first schedule of this Law

Capital Expenditure

(2) The sum of Eighty-Seven Billion, Three Hundred and Twenty-Three Million, Three Hundred and Seventeen thousand, Five hundred naira, Twenty-Three Kobo (N87,323,317,500.23) only shall be appropriated as Capital Expenditure as specified in the Second Schedule of this Law.

Total Expenditure

(3) The sum of One Hundred and Thirty-Seven Billion, One Hundred and Eighty-Two Million, Six Hundred and Nine thousand, One Hundred and Forty-Nine Naira, Fifty-Four Kobo (N137,182,609,149.54) only shall be the total 2020 Revised Appropriation of Niger State as specified in the Third Schedule to this Law
