1 Summary of Performance

1.A Introduction

This Budget Performance Report for Niger State is prepared quarterly and issued within four weeks from the end of each quarter.

This report includes, the approved original budget appropriation for the year 2021 (no supplementary or revised budget has been passed to date) against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 2 performance is assessed against the 2021 original budget. Given the trends in the implementation of 2021 Budget, the possibility of revised budget is being considered.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Account General Department/ Ministry of Finance/ Ministry of Planning and Budget/ Niger State equivalent, and published on the Niger State website.

1.B Revenue Performance

The 2021 Budget Revenue Components are made up of the following:

The sum of \$15,840,770,392.90 was Budgeted out of which \$7,976,625,689.82 representing 50.8% was realised as at the end of Q2. Revenue performance in this

quarter is relatively good in view of the prevailing economic situation of the State. The impressive performance was as a result of put in place towards addressing leakages and the full implementation of Treasury Single Accounts which compels all Revenue Generating MDAs to remit all revenues to the Consolidated Revenue Fund Account of the State. It is also a reflection of Change of Leadership in the State Revenue service.

The Total Revenue (Including Opening Balance) Budgeted was \\$155,176,015,747.17 out of which \\$38172085031.75 was realised representing 34.3% as at the end of Q2. The situation will improve in the course of the year in view of the increasing price oil in the International market, improved market condition and Strategies put in place to boost internal revenue generation.

1.C Recurrent Expenditure Performance

Total Budgeted Recurrent Expenditure stood at N82, 583,201,831.47 out of which N48, 293,703,702.27 or 58.48% is Personnel Cost while Other Recurrent Expenditure (Overhead Cost) stood at N34, 289,498,129.20 representing 41.52%. Out of the Personnel Cost of N48, 293,703,702.27, N18, 498,192,220.16 was expended representing 38.3% which clearly shows the commitment of Government to the payment of Salaries and Wages. The sum of N12, 656,415,417.07 representing 36.9% was expended under other recurrent cost. On the whole, the sum of N31, 148,607,637.23 or 37.7% was expended on recurrent expenditure. The expenditure was to meet smooth operation of government machinery and state exigencies particularly curbing security challenges.

1.D Capital Expenditure Performance

Capital Expenditure was allocated the sum of \(\pm\)70,829,419,944.90 or 46.17% of the entire Budget Size. The sum of \(\pm\)12,129,851,201.66 or 17.1% was expended as at the end of second quarter on ongoing Projects in the areas of Renovation and Construction of

infrastructure, provision of Water Supply, Electrification, Human Capital development and Public buildings across the state.

1.E Recommendation:

Arising from the above, the following recommendations are here by proffered:

- a. The capacity of Niger state internal revenue service and other revenue generating agency should be strengthened with modern technology and logistics.
- b. Expansion of Tax Payer Net to capture more taxable individuals and organizations in to the tax net.
- c. Prompt payment of counter-part funds requirements to attract more intervention by Development Partners for the development of the State.
- d. Government will continue to block leakages in the procurement process and reduced cost of governance.
- e. Needs to prepare revised Budget/virement to address likely overexpenditure in some Heads.
- f. There is also the need to review expenditure patterns so as to allow more resources for capital expenditure.
- g. Continuous Budget monitoring to ensure value for money.

1.F Conclusions

Shortfall from the FAAC Account and Security challenges in the State have negatively impacted in the Budget implementation. There is therefore the need to reduce over dependence on statutory allocation and enhance our IGR collection. Hence the need for exploration of new sources of revenue. Also, the State is about preparing a revised Budget to address issues of over-expenditure and re-alignment of Priorities.
