

LAW TO PROVIDE FOR

NIGER STATE APPROPRIATION, 2023

BE IT ENACTED by the House of Assembly of Niger State of Nigeria and by the authority of same in the present State Assembly as follows:-

Short Title and Commencement

- 1. This Law may be cited as Niger State Appropriation Law, 2023 and shall come into operation on 1st day of January, 2023.
- 2. By virtue of Section 121 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), Appropriation Law of Niger State for the period 1st January to 31st December, 2023 shall be as set out in the Schedule.

Recurrent Expenditure

3. (1) The sum of Ninety-One Billion, Three Hundred and Eighty-One Million, One Hundred and Sixty-One Thousand, Seven Hundred and Seventy-Five Naira, Seventy-Six Kobo only (N91,381,161,775.76) shall be appropriated as Recurrent Expenditure as specified in the First Schedule of this Law.

Capital Expenditure

(2) The sum of One Hundred and Fifty-Two Billion, Two Hundred and Sixty-Six Million, Twenty-Eight Thousand, Two Hundred and Three Naira, Twelve Kobo (N152,266,028,203.12) shall be appropriated as Expenditure for Capital Projects as specified in the Second Schedule of this Law.

Total Budget Size

(3) The sum of Two Hundred and Fourty-Three Billion, Six Hundred and Fourty-Seven Million, One Hundred and Eighty-Nine Thousand, Nine Hundred and Seventy-Eight Naira, Eighty-Eight Kobo only (N243,647,189,978.88) shall be the total 2023 appropriation of Niger State as specified in the Third Schedule to this Law.
