## **NIGER STATE EXECUTIVE ORDER No. 4 OF 2023**

### **PROMOTION OF TRANSPARENCY AND EFFICIENCY IN THE BUSINESS ENVIRONMENT IN NIGER STATE.**

WHEREAS, Niger State Government (hereinafter referred to as "the State") is enacting a policy to create an enabling environment for businesses and entrench measures and strategies aimed at promoting transparency and efficiency.

THEREFORE, In exercise of the powers conferred on me by section 5 (2) and 179 of the constitution of the Federal Republic of Nigeria 1999 (as amended) and all powers enabling me in that regard, I, Mohammed Umaru Bago, the Governor of Niger State of Nigeria, do hereby make the following Order for the good Governance of Niger State;

1. This Order may be cited as "The Promotion of Transparency and Efficiency in the Business Environment Order (No. 4) 2023";

2. This Order shall commence on the 20<sup>th</sup> day of December, 2023;

3. This Order, unless the context otherwise requires:

"GRM" means Grievance Redress Mechanism.

"MDA" means Ministries, Departments & Agencies.

"SLA" means Service Level Agreement.

"STATE" means Niger State of Nigeria.

4. It is hereby ordered that the under listed Ministries, Departments and Agencies (MDAs) of Niger State shall publish on State official website(s) all relevant information on fees, procedures, Service Level Agreements (SLAs), Grievance Redress Mechanism (GRM) for all core business regulatory processes provided by the MDAs;
5. It is hereby Ordered that the MDAs shall publish on State Official Website(s) advance communication rules of upcoming changes to the information on any of the items in (1) above and such changes shall come into effect only after a minimum of 30 days after the date of notice of the changes;
6. It is hereby Ordered that the MDAs shall provide contact information (telephone or email) which must remain functional during working hours;
7. It is hereby ordered that this Order is applicable to:
  - a) **Niger State Water Board, Minna;**
  - b) **Niger State Motor Vehicle Administration Agency;**
  - c) **Niger State Signage and Advertisement Agency;**
  - d) **Niger State Public Private Partnership Agency; and**
  - e) **Niger State Export and Commodity Promotion Agency;**
8. Where any of these Executive Orders is contravened by any MDA(s), the State Government shall take appropriate measures to sanction the violator.
