PROCEDURES, FEES AND SERVICE DELIVERY TIMELINES

WHO WE ARE:

The Niger State Signage and Advertisement Agency is established by the Niger State Law Notice No. 4, Vol. 23 in May 10th, 2018. And is responsible for regulating and controlling outdoor advertising and signage displays in Niger State.

We are a Government Agency set to re-deline the signage and outdoor advertising industry through effective signage and outdoor advertisement regulation and civic beautification.

NISSAA holds a unique position to showcase permissible advertising formats that are aesthetically pleasing and environmentally friendly. As a result, NISSAA has set itself a target to encourage unique advertising formats on the streetscapes of Niger State in line with her vision.

WHAT WE DO

We are responsible for the management, regulation and control of the signage and outdoor advertising environment in Niger State. By implication, we are responsible for managing all forms of signage and outdoor branding opportunities in the state.

HOW WE DO IT

Our Agency has embarked on the implementation of a “Streetscape Optimization Process and System” (SOPS) for all facets of the City’s streetscape, including, signage of all forms, outdoor advertising, and government utilities within the Niger State boundaries.

OUR VISION

NISSAA's Vision is to establish a state-of-the-art Outdoor Advertisement Landscape that will sustainably promote socio-economic development and Civic Beautification of the state.

OUR MISSION

Our Mission is to Modernize, Standardize and Regulate Streetscapes so as to benefit the State, Citizens and Visitors alike.

OUR CULTURE

Our Culture is one of sustained excellence in Service Delivery that draws upon Individual and Collective Performance that is empowered to continually innovate, improve, grow and develop in character.

First Party Sign Applications

First Party signs are signs that inform the public of the existence of a business at the location of display.

Application Process

This is the process during which an assessment of the proposed/existing sign is carried out in relation to the building/premises to determine suitable placement, size and display in line with the specifications of the NISSAA law and guideline.

- Applicant should obtain the applicable application form from the nearest NISSAA area office resident in the Local Government or Development Area offices after He/She must have paid for registration fee into the Agency's designated bank account.
- The completed form should be returned to the point of collection with the following requirements:

1. Photograph (for existing structure) or photomontage (for proposed structure). This should be taken or done in such a way that the entire building on/in front of which the sign is to be installed is captured thereby showing the existing signage on the building, the road and its setback. This will enable the processing officer make appropriate decision without visiting the site.

2. Payment Teller for the Application processing fee.

This payment depends on the present use of the property as below:

Consent letter from property's owner.

- In some cases, Client is advised to obtain the required approval before deployment of the sign. This takes a maximum of ten (10) days from the date of submission of application form(s).

3rd Party Application process

Third Party Sign (Off premise sign) is any sign identifying or advertising anything which is not produced, procured, sold, delivered, performed or provided from the premises on which the advertisement/sign is displayed.

The third-party application process is split into 2 major stages namely the pre-scrutiny process and the formal application process.

The Pre-scrutiny Process

The applicant is expected to visit NISSAA Head Office and submit with the following documents:

- Photomontage of proposed structure or picture of structure (in relation to the road)□
- Location map□
- G.I.S/Coordinates□
- Owners Consent where applicable□
- Copy of receipt of payment to Landlord where applicable.□

This information is required for the Agency to take a decision on the application. The application could either be approved, disapproved or subjected to site inspection. If the application is approved, it moves to formal application stage.

The Formal Application Process

Obtain Third party (B) form from NISSAA Head Office and submit with the following documents within 21 days:

- Form B□
- Site plan -scale□
- Structural drawing (showing company's name tag)□
- Electrical details-scale 1:100□

- Elevation drawings (front and side elevations)
- Copy of receipt of payment to Landlord where applicable
- Environment Impact Assessment (E.I.A) from Niger State Urban Development Board
- All drawings must be certified by a COREN Structural Engineer

If the application is successful, the Outdoor Advertising Agency will be issued an approval letter with a bill to be paid within a specified time.

FIRST PARTY REGISTRATION FEES:

Corporate Entities

Financial Institutions, Telecommunications Companies, Private Hospitals/Schools & Other Corporations.

(e.g Banks, Pensions, Insurances & Manufacturing Companies) **20,000.00**

Individual Businesses

These are persons, Businesses and organization who have signage exposures advertising their businesses with their business premises. **15,000.00**

Third Party

These are licensed Professional Advertisers who owns and operate Billboards for commercial use within the State.

BELOW ARE THE APPLICATION PROCESS FOR THIRD PARTY AND THEIR FEES:

- **Expression of Interest /Application Fee for Practice = 30,000.00**
- **Acceptance Fee = 30,000.00**
- **Application Per Site = 30,000.00**
- **Setting out Per Site = 30,000.00**
- **Annual Practicing Fee = 200,000.00 (paid Annually)**

PROCEDURES FOR CORPORATE AND INDIVIDUAL BUSINESSES

- Issuance of Demand Notice or Business owners can come on their own for enquiries and onward compliance.
- Issuance or collection of registration teller
- Payment of stipulated fees into the Agency's designated Bank Account domiciled at Unity Bank
- Presentation of "**evidence of payment**" by the Client to the Agency's Offices nearest to you.
- Issuance of "**FORM A**" which is to be filled and returned to the point of collection for proper documentation.
- The completed form should be returned with the following requirements:

- **1. Photograph (for existing structure) or photomontage (for proposed structure).** This should be taken or done in such a way that the entire building on/in front of which the sign is to be installed is captured thereby showing the existing signage on the building, the road and its setback. This will enable the Agency make appropriate decision without visiting the site.
 - The Assessment Officer will carried out an assessment of the client's publicity item(s) in and around their businesses for onward generation of Annual Advertisement Tax Bill.
 - Issuance of generated Advert Tax Bill for onward compliance by means of payment into Government Harmonized Revenue Account domiciled at UBA.
 - To aid clarification, charges are based on signage dimension (in square meters), signage type, and business location.
- Issuance of **Reminder, Final Reminder and Enforcement Notice** in the case of noncompliance (**i.e, at the interval of Seven (7) days from each notice**).
- Enforcement activity shall be carried out on defaulters who fail to comply after the above procedures.
